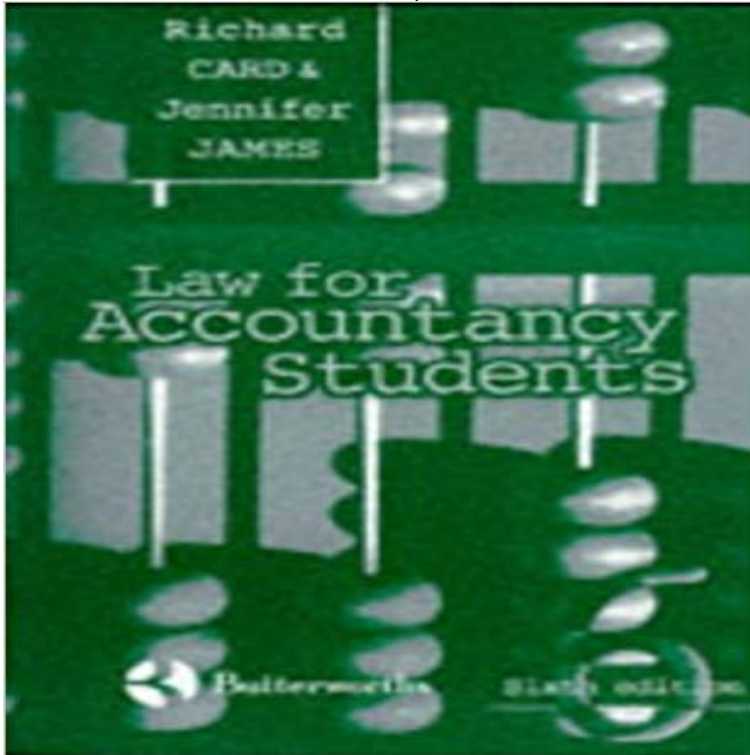


Law for Accountancy Students
