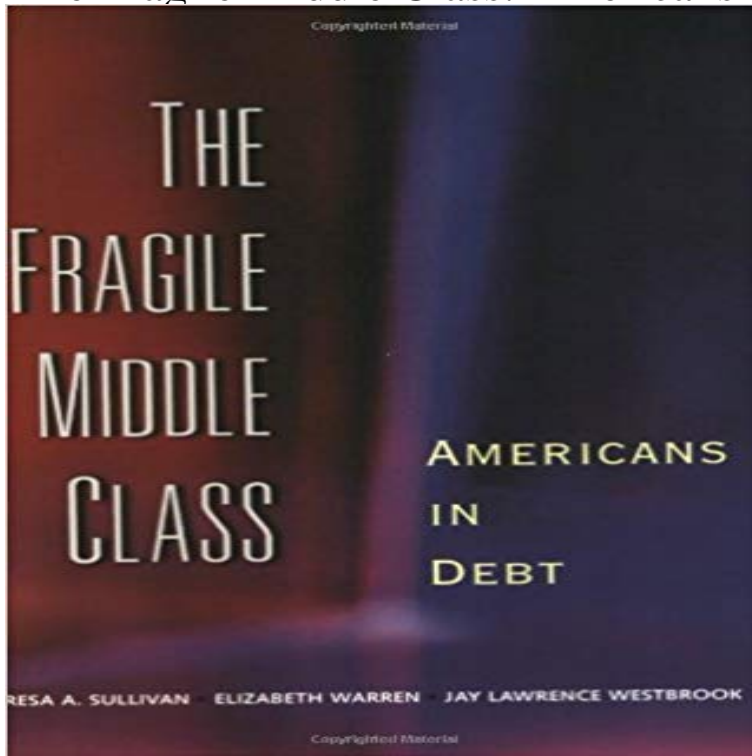


The Fragile Middle Class: Americans in Debt
